**Section A: Authorization to Disclose Information**

By signing this form, I (the student) do hereby authorize the release of personally identifiable student record information, pertaining to myself, to my high school officials, college personnel at schools I register at as a DE student for the purposes of consortium agreement, and my parents and/or legal guardians. This information may include, but is not limited to, academic, financial aid, and student account records that are otherwise confidential pursuant to the Family Educational Rights and Privacy Act (FERPA, 20 U.S.C. 1232g) and/or the Tennessee Public Records Act (T.C.A. § 10-7-504).

**Section B: Parent/Guardian Acknowledgement**

I give permission for my student to enroll in a DE program. I understand and agree to the following conditions:

1. I understand that by allowing my student to participate in the DE program, my student is responsible for following the guidelines and academic calendar of the high school **and** college.
2. A student must maintain a cumulative 2.0 GPA for all college courses certified under the Dual Enrollment Grant (DEG) or a cumulative 3.0 GPA under the Middle College Scholarship (MCS). Students who do not maintain the minimum GPA will no longer be eligible for the DEG or MCS and may be withdrawn from the college.
3. **All fees must be paid by the first day of class.** All costs associated with enrollment in college courses shall be the responsibility of the high school, student, or their parent or legal guardian. I promise to pay all fees and charges related to the student's DE if the DEG or MCS does not cover all tuition expenses or if the student does not qualify for the grant.

**Section C: Information for Simultaneous Enrollment at Two or More Colleges**

1. It is possible for a dual enrollment student to enroll at two or more colleges (2-Year / 4-Year / TCATS) simultaneously and receive the Dual Enrollment Grant at all eligible schools. This process has important implications for eligibility to consider.
  - a. The first college a student indicates on their DEG application is the first one permitted to certify DEG awards for payment in the state financial aid system. Secondary colleges (if applicable) cannot certify until the first college completes the process.
  - b. Each institution processes the DEG based upon the number of courses the student is enrolled in at the institution.
  - c. If a student simultaneously enrolls at a TCAT, the grant certification for clock hours at the TCAT is separate from certification at 2- and 4-year colleges.
2. The grades for courses at like institutions (TCAT to TCAT or 2-/4- year to 2-/4- year) during the term of enrollment where DEG is received impacts the GPA used for continuing eligibility for the DEG. DEG eligibility for a subsequent term cannot be determined until all like schools report grades to the state financial aid system.
3. Anyone considering simultaneous enrollment is highly encouraged to contact their high school counselor who works with Dual Enrollment.

**Section D: Immunization Health History**

The General Assembly of the State of Tennessee mandates that each public or private postsecondary school in the state provide information concerning measles, mumps, rubella, varicella, and hepatitis B infections to all students matriculating for the first time. Tennessee law requires that such students complete and sign a waiver form provided by the school that includes detailed information about these diseases. The information below includes the risk factors and dangers of these diseases as well as information on the availability and effectiveness of vaccines for persons who are at-risk for these diseases. The information concerning each disease is from the Centers for Disease Control and the American College Health Association. The law does not

require that students receive vaccination for enrollment. Furthermore, the school is not required by law to provide vaccination and/or reimbursement for the vaccine.

### **Hepatitis B (HBV) Immunization**

Hepatitis B (HBV) is a serious viral infection of the liver that can lead to chronic liver disease, cirrhosis, liver cancer, liver failure and even death. The disease is transmitted by blood and or body fluids and many people will have no symptoms when they develop the disease. The primary risk factors for Hepatitis B are sexual activity and injecting drug use. This disease is completely preventable. Hepatitis B vaccine is available to all age groups to prevent Hepatitis B viral infection. A series of three (3) doses of vaccine are required for optimal protection. Missed doses may still be sought to complete the series if only one or two have been acquired. The HBV vaccine has a record of safety and is believed to confer lifelong immunity in most cases.

### **Measles, Mumps, Rubella (MMR) and Varicella Immunizations**

Measles, causes fever, rash, cough, runny nose, and red, watery eyes. Complications can include ear infection, diarrhea, pneumonia, brain damage, and death.

Mumps causes fever, headache, muscle aches, tiredness, loss of appetite, and swollen salivary glands. Complications can include swelling of the testicles or ovaries, deafness, inflammation of the brain and/or tissue covering the brain and spinal cord (encephalitis/meningitis), and, rarely, death.

Rubella causes fever, sore throat, rash, headache, and red, itchy eyes. If a woman gets rubella while she is pregnant, she could have a miscarriage, or her baby could be born with serious birth defects.

Varicella (chickenpox) causes blister-like rash, itching, fever, and tiredness. Complications can include severe skin infection, scars, pneumonia, brain damage, or death.

You can protect against these diseases with safe, effective vaccination.
